In response to a question about conducting “Webinars,” John described the following process for setting one up:

Electronic brochure is sent out by the Society to attract participants.

Barry Midwood, Vice President of Member and Professional Services with the Society attended the meeting to discuss the web site problem we had on Thursday, April 3<sup>rd</sup>. Barry informed us that the discussion site had been shut down on Friday, April 4th and an e-mail announcement sent to CLEW members apologizing for the inconvenience. Barry will work with the Society’s vendor to see how we can avoid this type of problem in the future. The goal is to reestablish the Discussion Site in a manner that works for and does not overwhelm CLEW members.

Norm Steinberg asked Barry about the Society’s efforts in helping members seeking employment or employees. Barry answered with a brief description of the Career Center/ Job Network on the Society’s web site where CPCU’s can post their resumes and employers can post jobs.

## 11) New Business

### **Interest Group Changes**

Greg Deimling reported on recommendations made to the Society by the Interest Group Resource and Governance Task Force. These include:

Expanding the number of Interest Groups from the current 14 to as many as 25  
20% of our members don't fit into any of our current Interest Groups.

Redesign Interest Groups to make more and better use of technology  
To support expansion of # of Interest Groups;  
Change the working model to be more fluid and allow more interaction; and  
"Virtual Community" concept.

### **Society Changes**

Greg Deimling also reported on a number of changes that the Society's Board as accepted for implementation. These include:

Reducing the number of board positions from 43 to 18;  
Making the Secretary/Treasurer position two separate ones;  
Renaming the Board members "Directors";  
Adopting the "Shared Vision" joint effort with the Institutes to increase matriculation;  
and  
Changing governance to be Chapter orientated.

### **Potential New Members of CLEW Committee**

Donn McVeigh stated that will conclude his Committee membership with the Annual Meeting in Philadelphia. There was a discussion about adding new members to the committee including Stanley Lipshultz and Bob Siems. Dan Free, Lawton Swan, Greg Deimling and Steve Stinson asked to receive a roster of CLEW members so that they could consider possible additions to the Committee. Chip Boylan will send the roster to them. New committee members are appointed by the President-Elect (currently Marvin Kelly).

### **Other**

Norm Steinberg asked the Committee members if anyone knew of a group similar to CLEW that we could meet with during a (to be planned) trip to England after the Philadelphia Annual meeting. Greg Deimling mentioned of the Society's Europe Chapter as a possibility. The conclusion was that Norm would investigate this further and that committee members should let Norm know if they become aware of any possible connections in England.
